

## **LED Luminaire Five Year Limited Warranty**



*"Lighting the future of America"*

LED North America warrants that the below-referenced lamps comply with their published specifications and are free from defects in materials and workmanship for the respective periods of time set forth below.

If an LED North America LED luminaire mentioned below fails due to defects in materials or workmanship within the indicated time period, then LED North America will provide an equal or superior replacement luminaire to the direct purchaser ("Purchaser"). This warranty applies only to luminaires that have been properly wired and installed and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the Lamp.

- **Manhattan High Bay**
- **Trinity High Bay**

If an LED North America luminaire fails due to defects in materials or workmanship within FIVE (5) years after the date of purchase, then LED North America will provide a replacement luminaire of equal or superior quality if failure is within the first five (5) years. This warranty applies only to LED North America luminaires that have been properly wired and installed; operated within the electrical values shown on the luminaire label; and operated in lighting equipment designed and approved for the application and in environmental conditions (temperature, humidity and air movement) within the normal specified operating range of the system.

### **Terms & Conditions:**

The foregoing luminaire warranty applies only to direct purchases from LED North America or one of our approved independent representatives, but do not apply to failures caused by acts of God or as a result of any abuse, misuse, abnormal use, or use in violation of any applicable standard, code or instructions for use in installations, including, but not limited to, those contained in the National Electrical Code, the Standards for Safety of Underwriters Laboratory, Inc., Standards for the International Electrotechnical Commission (IEC), Standards for the American National Standards Institute or, in Canada, the Canadian Standards Association. LED North America *reserves and has the right to examine failed luminaires to determine the cause of failure.* The date of purchase and luminaire installation date must be verified to validate if a warranty claim is made.

The foregoing warranties constitute the sole and exclusive remedy of the purchaser and the sole liability of LED North America for luminaire warranties. **NO WARRANTY OF**

**MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS MADE OR IS TO BE IMPLIED.** In no event shall LED North America be liable for any other costs or damages including lost profits, indirect, incidental, special or consequential damages.

### **To Make a Warranty Claim:**

Return the failed products and notify your LED North America sales representative within thirty (30) days of the failure. This warranty extends only to Purchaser. However, LED North America will honor, under the terms of this Limited Warranty, valid warranty claims made by Purchaser for the remedy set forth above as a result of warranty claims made to Purchaser by its customers if an authorized reseller.
